Proceedings of the Meeting:

Chairman IQAC invited all the members of IQAC to this meeting. The following points were discussed in the meeting.

Item 1 : New Vision and Mission of the Institute

Resolution : The Chairman announced that the institute has received a second cycle extension of accreditation from NAAC, and all undergraduate programs are accredited by NBA. Acknowledging the significance of adhering to accreditation standards, the institution has initiated the process of revising its Vision and Mission statements.

Following extensive consultation with all stakeholders, the institution has crafted new Vision and Mission statements that underscore its dedication to excellence and adherence to accreditation criteria. These proposed statements were formally presented during the Board of Governors meeting held on 24.3.2021, following the collection of stakeholder feedback from 1.3.2021.

The Board of Governors members unanimously approved the new Vision and Mission statements during the meeting and subsequently communicated them across all areas of the institute.

Institute Vision and Mission

Vision:

To produce competent professionals who can contribute to the industry, research and societal benefits with environment consciousness and ethical values.

Mission:

M1: Adapt continuous improvements in innovative teaching-learning practices and state-of-the-art infrastructure to transform students as competent professionals and entrepreneurs in multi-disciplinary fields.

M2: Develop an innovative ecosystem with strong involvement and participation of students and faculty members.

M3: Impart National development spirit among the students to utilize their knowledge and skills for societal benefits with ethical values.

Item 2: New Vision and Mission of CSE and MECH department

Resolution : The IQAC Coordinator highlighted that the Computer Science and Engineering (CSE) and Mechanical Engineering (MECH) departments are accredited by NBA. In line with the commitment to accreditation standards, both departments have embarked on the process of revising their respective Vision and Mission statements.

Expert members were appointed within each department to formulate the new statements, incorporating input from stakeholders. The Departmental Advisory Committee (DAC) meeting for the CSE department took place on April 18, 2021, following the collection of stakeholder feedback from April 1, 2021. Minor corrections were made, and the DAC members approved the new Vision and Mission statement for CSE.

Similarly, the DAC meeting for the MECH department occurred on April 24, 2021, with stakeholder feedback collected from April 6, 2021. After incorporating minor corrections, the DAC members

approved the new Vision and Mission statement for MECH. The approved statements for both departments were subsequently disseminated across all departmental areas.

CSE VISION AND MISSION

Vision:

To produce technically competent professionals with quality education in cutting edge technologies with professional ethics.

Mission:

M1:To impart quality technical education in design and implementation of IT applications through innovative teaching - learning practices.

M2: To inculcate Professional behavior, with strong ethical values, and research capabilities. M3: To educate students to be an effective problem solver with social sensitivity for the betterment

M3: To educate students to be an effective problem solver with social sensitivity for the betterment of the society and humanity.

Vision:

MECH - Vision & Mission

To provide a professional and conducive environment to foster outcome-based teaching learning with intellectual, ethical, and cultural sensitivities to lead in the field of Mechanical Engineering.

Mission:

M1: To produce skilled graduates with leadership qualities and team working abilities, thus enhancing their employability and self-sustainability in the environment.

M2: To emerge as a centre for research & consultancy in the field of Mechanical Engineering and be an incubation centre for Technocrats.

M3: To inculcate the habit of continuous learning through advanced technologies with ethical values.

Item 3: Discussion on feedback rubrics

Resolution: IQAC Coordinator presented the weighted rubrics for the feedback analysis. For feedback pertaining to gap identification and PO attainments the weight given to alumni and recruiters will be more than that of the students and parents. For the feedback pertaining to infrastructure, mentoring, subject feedback, events organized, etc. all the concerned stakeholders will have the same weightage.

Item 4: Discussion on Process of Gap Identification

Resolution: The IQAC coordinator presented the process of GAP identification as proposed by HOD ECE. The IQAC members approved the process with modification to include weighted feedback for gap identification process.

Item 5: Discussion on Academic Audit report

Resolution: HOD of all the departments briefly discussed the academic audit report of their respective departments.

Item 6: Discussion on PO/PSO attainment from BEES tool

Resolution: The Controller of examination explained the process of PO/PSO attainment from BEES tool. The HoDs of all the departments were requested to prepare the CO statements and CO-PO mapping details based on the template provided by the exam section for their respective branches.

Item 7: Discussion on Online feedback summary

Resolution: The IQAC members discussed the issues faced during collection of online feedback. It was resolved to allow anonymous submission of the online form submission excluding the sections submitted by recruiters.

Item 8: Discussion on Activities conducted by Entrepreneurship Cell

Resolution: The Entrepreneurship Development Cell coordinator presented the details of EDC activities conducted in previous semester and the plans for upcoming semester.

Item 9: Discussion on Faculty appraisal

Resolution: The IQAC coordinator presented the methodology adopted for faculty appraisals. The IQAC members approved the process.
