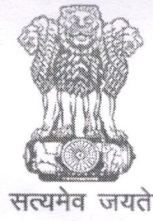

This is with reference to the proposal submitted by Narsimha Reddy Engineering College, S.no: 518, Maisammaguda (v), Dhulapally (post), Secunderabad, Medchal – 500100 affiliated to Jawaharlal Nehru Technological University, Hyderabad under the UGC Scheme for Autonomous Colleges.

As per the decision of the Standing Committee constituted by University Grants Commission, in its meeting held on 11.02.2021, the Competent Authority has decided to grant autonomous status to **Narsimha Reddy Engineering College, S.no: 518, Maisammaguda (v), Dhulapally (post), Secunderabad, Medchal – 500100** affiliated to **Jawaharlal Nehru Technological University, Hyderabad** for a period of Ten (10) years from the session 2020-2021 to 2029-2030 as per provisions of Clause 3.13 and Clause 6.4 (i) of UGC Regulations dated 12.02.2018.

The University is requested to issue necessary notification/order regarding the grant of autonomous status to the college as per UGC (Conferment of Autonomous Status Upon Colleges and Measures for Maintenance of Standards in Autonomous Colleges) Regulations, 2018 for Autonomous Colleges. The college, if eligible, shall apply for autonomy grant as per the norms laid down in the Regulations.

The autonomous college is required to abide by all the provisions of the UGC Regulations for Autonomous Colleges. The Regulations are available on the UGC website, www.ugc.ac.in. Non compliance of the requirements and conditions in the said Regulations shall attract action as per Clause -14 of the UGC Regulations – 2018. The college shall also apply in the prescribed format to University Grants Commission for extension of autonomous status six months prior to the expiry of the autonomous cycle.

VIII. Admission Policy & Process

B. TECH:

Admissions to B. Tech is done through a common entrance test (EAMCET) conducted by the State Government.

The minimum qualification for admission to first year of the B. Tech course is a pass in the Intermediate (10 + 2) conducted by the board of Intermediate education, or any other examination recognized as equivalent there to with Mathematics, Physics and Chemistry.

- 70 % of the seats are allotted based on the merit in the EAMCET by university.
- 30 % of the seats are earmarked for Management/NRI candidates by the institute.
- In addition to the above, Diploma holders are admitted in second year of B. Tech to the extent of 10% of intake based on the merit in the ECET, under lateral entry scheme.

MBA:

The minimum qualification for admission to first year of the MBA is a pass in undergraduate course (10 + 2 + 3).

- 70% of the seats are allotted based on the merit in the ICET by university.



